



Contest Purpose:

- To offer one Grand Prize Winner a \$50,000 shopping spree at the Mall (the "Contest").

Definitions

BCLC means the British Columbia Lottery Corporation.

Contest Period means from 12:00:00 am PT on September 5, 2017 to 11:59:59 pm PT on October 1, 2017.

Day means 12:00:00 am to 11:59:59 PT on any one calendar day.

Drawn Entrant(s) means a Qualified Entrant whose name is drawn as a result of the Grand Prize Draw.

Event Staff means any individual authorized by BCLC to oversee this contest.

Grand Prize has a maximum value of approximately \$54,000.00 and consists of the Shopping Spree plus the applicable Travel Component.

Grand Prize Draw means the draw scheduled to take place at BCLC's Vancouver office on October 4, 2017, or as soon as practical thereafter.

Grand Prize Winner means the Drawn Entrant who fulfills and agrees to all contest conditions herein including correctly answering a skill testing question and signing the Winner's Authorization Form.

Green Room means a secured location provided by the Mall, which can be used at Grand Prize Winner's discretion to store his/her purchases during the Shopping Spree Period.

Lottery Retailer means a person contracted by BCLC to sell lottery tickets and provide lottery services at a retail location or a person who is an employee or volunteer at a retail location contracted by BCLC and is authorized to operate a lottery terminal.

Mall means Metropolis at Metrotown shopping centre, located at 4700 Kingsway, Burnaby, BC, V5H 4N2.

Merchandise means anything purchased by the Grand Prize Winner during the Shopping Spree Period with the Mall gift cards.

Qualified Entrant means:

- Someone who is 19 years of age or older and is a resident of British Columbia.

But does not include:

- BCLC employees as well as family and household members of same who reside at the same address;
- Lottery Retailers as well as family and household members of same who reside at the same address;
- Individuals who are currently self-excluded or who self-exclude at any time during the Contest Period from BCLC;
- Individuals that are currently barred from a BCLC gaming facility, or are barred at any time during the Contest Period; or
- Individuals who submit more than one (1) entry per Day and/or used (or attempted to use) multiple names, identities and/or more than one (1) email address to enter the Contest.

Shopping Spree means:

- Up to One Hundred (100) Mall gift cards, each with a value of \$500.00 that the Grand Prize Winner must spend during the Shopping Spree Period and in accordance with the conditions herein.

Shopping Spree Period means from 12:15 pm to 4:30 pm on October 28, 2017.

Travel Component means

EITHER:

1. In the event that the Grand Prize Winner's mailing address is located outside a one hundred (100) kilometer radius from the Mall, the Grand Prize Winner shall receive:



- a. At the Grand Prize Winner's discretion, either:
 - a. Return airfare for two (2) to Vancouver, BC from the BC airport location nearest the winner's mailing address; or
 - b. In the event that the Grand Prize Winner decides to drive to the Mall, seven hundred fifty dollars (\$750.00) towards the Grand Prize Winner's ground transportation costs;
- b. If applicable, return ground transportation from Vancouver Airport to Hilton Vancouver Metrotown hotel (the "Hotel") or similar;
- c. Accommodation for two (2) on October 27th and October 28th, 2017 based on double occupancy at the Hotel ; and
- d. Five hundred dollars (\$500.00) spending money;

OR:

2. In the event that the Grand Prize Winner's mailing address is located within a one hundred (100) kilometer radius from the Mall, the Grand Prize Winner shall receive:
 - a. Return ground transportation from Grand Prize Winner's mailing address to the Hotel or similar;
 - b. Accommodation for two (2) on October 27th and October 28th, 2017 based on double occupancy at the Hotel ; and
 - c. Five hundred dollars (\$500.00) spending money.

Verification Process means the process by which BCLC will verify that a Drawn Entrant is entitled to the Grand Prize. The process consists of the following:

- a. Once a Drawn Entrant is selected, a BCLC representative will attempt to contact the Drawn Entrant by email using the contact information provided in the Drawn Entrant's entry within two (2) days of the Grand Prize Draw.
- b. The Drawn Entrant will then have three (3) days from BCLC's notification email to respond to BCLC via email and accept the Grand Prize. If no response is received, BCLC may, at its sole discretion, determine the Grand Prize is forfeited and another Drawn Entrant will be selected as the Grand Prize Winner.
- c. Once a Drawn Entrant accepts the Grand Prize, BCLC will provide the Drawn Entrant with a skill testing question and a copy of the Winner's Authorization Form. The Drawn Entrant will have three (3) days to correctly answer the skill testing question and return a signed Winner's Authorization Form along with a copy of valid photo identification to BCLC.
- d. Upon request, the Drawn Entrant must provide BCLC with proof of age and residence.

Winner's Authorization Form means such representations, indemnities and releases as BCLC may require in its sole discretion from the Drawn Entrant in consideration of and in order to induce BCLC to deliver the Grand Prize to the Drawn Entrant.

How to Enter:

1. No purchase is necessary however, entrants must have access to a computer or similar device with an Internet connection and an email address.
2. Qualified Entrants may register and enter the Contest by following the instructions and submitting a completed entry form at DailyGrandContest.com. Each entry form submitted during the Contest Period will result in one (1) entry in the Contest. Qualified Entrants may submit only one (1) entry per Day during the Contest Period and must use the same email address for all entries.
3. Entry forms will be invalid if the entry form is not fully completed, submitted and received during the Contest Period.

Grand Prize Draw

4. The Grand Prize Draw will take place on October 4, 2017 or as soon as practical thereafter to select, from all eligible entries received during the Contest Period, one Drawn Entrant to undergo the Verification Process.
5. In the event that the Drawn Entrant is unable to successfully complete the Verification Process, then he or she may, at BCLC's sole discretion, be deemed to have refused the Grand Prize and BCLC will undertake a new draw to select another Drawn Entrant who must successfully complete the Verification Process.
6. In order to participate in the Grand Prize, the Grand Prize Winner's guest must complete such authorizations, releases and indemnities as BCLC may require, in their sole discretion.



Grand Prize

7. The Grand Prize must be accepted as awarded and is not transferable.
8. Grand Prize Winner will be provided with contacts and instructions on how to proceed with bookings for the Travel Component once the Grand Prize is awarded.
9. Travel Component cannot be used towards another travel itinerary and cannot be exchanged for cash.
10. During the Shopping Spree Period, the Grand Prize Winner must complete purchases in at least eight (8) Mall stores.
11. If the Grand Prize Winner spends at least \$42,000.00 during the Shopping Spree Period, the Grand Prize Winner shall be entitled to retain the remaining balance on all remaining gift cards. Please note: if the gift card value has not been spent by May 28, 2018, a monthly maintenance fee of \$2.50 will be applied and deducted from the value of each gift card until such time as the gift card value is \$0.00.
12. If the Grand Prize Winner spends less than \$42,000.00 during the Shopping Spree Period, then the Grand Prize Winner is deemed to have forfeited the remaining balance on all remaining gift cards.
13. The Grand Prize Winner must provide receipts for all purchases to BCLC for verification of the total of the Grand Prize Winner's purchases.
14. During the Shopping Spree, the Grand Prize Winner may not use the gift cards to purchase gift cards from Mall merchants or purchase more than one hundred dollars (\$100.00) in total of lottery products.
15. The Grand Prize Winner is solely responsible for any additional expenses above and beyond the Grand Prize, including but not limited to:
 - a. Any secondary travel itinerary and/or accommodations including transportation to/from their residence to the Canadian departure airport; and
 - b. Any expenses incurred by the Grand Prize Winners or the winners' companion while they are partaking in the Grand Prize. I.e. Travel insurance, lost or stolen items, missed flights / connections, cancellation fees, change fees, meals, personal expenses, etc.

Shopping Spree

16. Prior to October 16, 2017, the Grand Prize Winner must provide BCLC with a list of at least eight (8) Mall stores at which the Grand Prize Winner intends to purchase Merchandise and a list of possible purchases.
17. The Grand Prize Winner must plan his/her transportation accordingly, in order to be present at a pre-event planning session on October 27th, 2017 at Hilton Vancouver Metrotown hotel at 6pm in order to:
 - a. Receive "Daily Grand" apparel;
 - b. Receive a briefing on the next day; and
 - c. Receive BCLC media training
18. BCLC strongly recommends that the Grand Prize Winner, if possible, undertakes a Mall visit in advance of the Shopping Spree Period to acclimate themselves to the Mall and its merchants.
19. The Grand Prize Winner must arrive at the Mall at least sixty (60) minutes before the Shopping Spree Period.
20. The Grand Prize Winner will be supplied with a Go-Pro camera and must wear the Go-Pro camera for the duration of the Shopping Spree Period.
21. Based on the list of Mall stores provided by the Grand Prize Winner, the Grand Prize Winner will be provided with a shopping schedule and must be present at the time of and authorize a purchase.
22. The Event Staff will provide the Grand Prize Winner with the Mall gift cards as required to complete purchases during the Shopping Spree.
23. The Grand Prize Winner must be present and authorize each purchase of Merchandise at the time of the purchase.
24. The Grand Prize Winner may, in his/her discretion, during the Shopping Spree Period:
 - a. Keep his/her Merchandise with them;
 - b. Put his/her Merchandise in the Green Room; OR,
 - c. Ask Event Staff to put the Merchandise in the Green Room.
25. The Grand Prize Winner must wear the "Daily Grand" apparel for one hour before and after, and during the Shopping Spree Period.
26. During the Shopping Spree, only the Grand Prize Winner is permitted to use the gift cards to purchase items.
27. The Grand Prize Winner must participate in BCLC interviews and photographs before, during and following the Shopping Spree and thus, must remain at the Mall for thirty (30) minutes following the Shopping Spree Period.
28. It is the Grand Prize Winner's sole responsibility to arrange, and pay for, if necessary, any and all costs associated with transporting the Merchandise from the Mall to the Grand Prize Winner's selected location.
29. BCLC will not be responsible for any damage to or loss of Merchandise at any time.

General Conditions

30. It is the responsibility of each Qualified Entrant to ensure that his or her submitted entry has current information, including a current telephone number and email address at which he or she can be contacted.



31. BCLC is not liable for entries that are late, lost, misdirected, delayed, incomplete, or not received.
32. In no event shall BCLC be liable for a Qualified Entrant not receiving notification of the fact that his/her name has been drawn.
33. By entering this Contest, each person consents to the collection, use, access, disclosure and storage of his or her personal information inside and outside of Canada.
34. BCLC are not liable for any loss or damage to any Entrant or their computer or any other property related to or resulting from participating in this contest or downloading any material related thereto.
35. BCLC shall not be liable to any person for loss or damage to person or property, related to or resulting from participating in this contest, whether or not resulting from or connected with acts or omissions of BCLC.
36. BCLC may, at their sole discretion and without liability to any individual or Qualified Entrant, alter, amend, change, modify, or suspend this Contest at any time and are not responsible for commencing, continuing or completing any event or awarding prizes, in the event of circumstances beyond their control.
37. BCLC reserves the right not to award a Grand Prize in the event that the integrity of all, or a part, of the Contest is compromised. Such a compromise shall include, but is not limited to, computer error, fraud, deception, misrepresentation or misuse.
38. BCLC reserve the right in their sole discretion, to substitute all or a portion of the Grand Prize with replacement prize(s) of equal or greater value.
39. In BCLC's sole discretion, the Grand Prize Winner may be permitted to assign one designate to undertake the Shopping Spree provided that the designate is acceptable to BCLC, meets all terms and conditions herein and executes the Winner's Authorization Form.
40. Each Grand Prize Winner and each Grand Prize Winner's guest will indemnify and save BCLC harmless from and against any and all actions, claims or demands by the Grand Prize Winner or the Grand Prize Winner's guest (including costs incurred by BCLC in defending such actions, claims or demands) brought against BCLC which arise out of or are in any way connected to the Grand Prize, including but not limited to, travel and accommodation.
41. In making the Grand Prize available to the Grand Prize Winner, BCLC makes no representations or warranties whatsoever either expressed or implied, oral or written in respect to the Grand Prize, any product or service purchased or associated with the Shopping Spree or any merchant or store visited by the Grand Prize Winner during the Shopping Spree.
42. Odds of winning are dependent on the number of entries received.
43. BCLC reserves the right to disqualify entrants and/or entries that do not comply with these conditions.
44. BCLC has the right to publish the name, address and a recent photograph of the Grand Prize Winner without liability or remuneration and in accordance with the terms of the Winner's Authorization Form.
45. In making the Grand Prize available BCLC makes no representations or warranties whatsoever, either expressed or implied, oral or written, in respect of the Grand Prize.
46. All stated values are in Canadian dollars.
47. All entries are the property of BCLC.
48. All decisions of BCLC are final and binding.
